## Payments

Prices are subject to change – please check before booking for current rates.

By paying any part of the invoice the hirer is also agreeing to the Terms & Conditions.

A \$200 deposit is necessary to secure the event time and date. Until a deposit is received, the date cannot be confirmed.

The outstanding amount must be paid by the hirer to PhotoBooth Events at least 14 days before the event.

If booked within 7 days of the event, non-refundable full payment must be received within 48 hours of booking.

A travel surcharge may apply to events outside of the Sydney metropolitan area.

An idle fee may apply for extensive waiting periods.

Certain dates may be subject to an additional surcharge.

Fancy dress props (if used) must be in good order at the end of the event, otherwise a charge may apply.

## GST

All prices are inclusive of GST unless otherwise stated.

## Cancellation

If the hirer cancels within 7 days of booking, the deposit will be returned in full.

Prior notice is required of changes to the time and date of the event. PhotoBooth Events cannot be held responsible for unforeseen delays at the venue.

## Privacy

PhotoBooth Events will not sell your details to any third party and will take reasonable measures to ensure that your details remain confidential.

PhotoBooth Events may contact you with future special offers.

## Hiring, delivery and service

Delivery, set up and removal of the PhotoBooth are free of charge.

Time taken to deliver, set up and remove the PhotoBooth will be outside the rental period.

A trained PhotoBooth Events operator will be with the PhotoBooth at all times to ensure smooth running.

At all times care will be taken by PhotoBooth Events to ensure delivery of high quality photostrips, however, should equipment failure or damage caused by personal injury or guests occur, liability is limited to monies paid.

## Use of images
